**AYUSH-National Eligibility Test, 2018 (AYUSH-NET, 2018)  
for Ph.D. Fellowships [Senior Research Fellowships (SRF)]**

1. The following Central Research Councils function under Ministry of AYUSH, Govt. of India to promote and coordinate research activities in the respective systems of medicine, as indicated below:
  - i. **Ayurveda:** Central Council for Research in Ayurvedic Sciences (CCRAS)
  - ii. **Yoga & Naturopathy:** Central Council for Research in Yoga & Naturopathy (CCRYN)
  - iii. **Unani:** Central Council for Research in Unani Medicine (CCRUM)
  - iv. **Siddha:** Central Council for Research in Siddha (CCRS)
  - v. **Homoeopathy:** Central Council for Research in Homoeopathy (CCRH)
2. **UGC has mutually recognized AYUSH-NET and UGC-NET for admission to the Ph.D. programme in the subjects covered under AYUSH except for those subjects in which UGC is conducting NET, such as "YOGA" and accordingly, the Ministry of AYUSH has requested all Universities to exempt AYUSH-NET qualified candidates from their own Entrance Test for admission to Ph.D. Programme.**
3. The CCRAS now invites application on behalf of the above five Central Research Councils for Ph.D. Fellowship- Senior Research Fellowships (SRF) through AYUSH-National Eligibility Test (AYUSH-NET) for the year 2018 as per following schedule.
  - i. **Date of AYUSH National Eligibility Test (AYUSH-NET)** - **13.11.2018**
  - ii. **Schedule for Online Application:**
    - (a) Start of Online Registration and Submission of Application Form and Fee Deposit through SBI Collect/Cash in SBI branch through challan - **20.09.2018**
    - (b) Date of close of Online Registration and Submission of Applications (at all stations) - **03.10.2018**
    - (c) Date of close of online submission of Application Fee through net Banking/Credit/Debit card on SBI Collect System (at all stations) - **04.10.2018**
  - iii. **Publication of list of candidates registered for test on websites given below at para 6** - **08.10.2018**
  - iv. **Issue of e-admission Certificate to registered candidates** - **23.10.2018**
4. **Essential Qualifications** for the Fellowship are:
  - i. Post Graduate (MD/MS) - for Ayurveda, Unani, Siddha & Homoeopathy, and
  - ii. Post Graduate [MD (Y/ N)] or Graduation (BNYS) with 5 years experience for Yoga/Naturopathy.
5. The fellowship will be provided for pursuing Ph.D. under a recognized University/Institution of choice by the candidates and during their fellowship, they will be termed as Senior Research Fellows (SRFs).
6. This scheme will also be open to Senior Research Fellows under various research schemes / projects of the Research Councils for each individual AYUSH stream for a specified duration. Such SRFs will also be permitted to complete Ph.D. while working with Council in their respective project / scheme, if enrolled.
7. **The test will be conducted online.** The interested candidates possessing the above-mentioned qualification (candidates appearing in final PG exams, shall have PG degree by 31st December 2018) may apply for their respective streams viz. Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy.
