# AYURVEDA STARTUP GRAND CHALLENGE:

The 8th Ayurveda Day embraces the theme "Ayurveda for One Health," resonating with India's G20 Presidency theme, 'Vasudhaiva Kutumbakam' (the world is one family). The central theme is encapsulated in the tagline "Ayurveda for everyone, every day," emphasizing the interconnection of human health with the environment, animals, and plants. It adopts a four-pronged "Jan Sandesh, Jan Bhagidhari, and Jan Andolan for Jan Arogya" approach, underscoring the Ministry of Ayush's commitment to holistic health through Ayurveda.

Recognizing the substantial potential of startups in the sector, the Ministry of Ayush and All India Institute of Ayurveda, in collaboration with Startup India and Invest India, are launching the Ayurveda Grand Startup Challenge. This initiative is designed to propel the theme and four key components, aligning closely with the vision of the Government of India.
