**1. Payment Terms: (Annexure – II – Financial Bid)**

- a) Payment for services listed at S.No. 1,2 & 3, shall be made within 30 days after installations of Tally software at all locations
- b) Payment for services at S.No. 4,5,6 & 8 shall be made after satisfactory completion of assigned tasks
- c) Payment for help desk for Tally support shall be made after satisfactory completion of services of 3 months.

2. **Annual Maintenance Contract (AMC)** : The AMC will be awarded after the expiry of Warranty period of 6 months of Tally Software from the date of installation and Payment of AMC will be half yearly basis on satisfactory services which include minimum one monthly visit to the office.
3. **PFMS**: Requirement of integration of tally with PFMS shall be taken up in 2<sup>nd</sup> Phase after implementation of Tally Package. So this item has now been deferred from current Tender document.
4. **Selection criteria**: Selection Criteria for financial bid shall be the total cost other than the cost of AMC.
