This is with reference to our Notification dated 13.07.2021, wherein an email was provided to the candidates, who appeared in the written examination, for viewing answer key of the written examination for selection of candidates for the post of Research Officer (Unani) held on 13.07.2021 at All India Institute of Local Self Government, Janakpuri, New Delhi. The candidates appearing in written examination had been allowed to take the Question paper alongwith them. The candidates were invited to forward their objection(s), if any, on the question paper/answer key within a period of 3 days till 5.00 PM on 16.07.2021.

- 2. Objections in respect of responses in the answer key for 9 (nine) questions were received from the candidates. The question numbers on which objections were received are Q.No. 17, 19, 21, 40, 42, 67, 88, 98 and 100. A Committee of External Subject Experts was constituted to examine the objections and make their recommendations. The Committee has examined the objections and made their recommendations. After consideration of the recommendations of the duly constituted Committee of External Subject Experts, it has been decided by the Competent Authority that:
 - The objections for answer given in the answer key for question No. 21, 67, 88 and 100 were not accepted as valid and hence no change in answer key is required.
 - ii. In respect of question No. 17, 40 and 42 the objections have been accepted and the following changes in the answer key are made:
 - a) The answer for question No. 17 is amended as (D) in place of (C).
 - b) The answer for question No. 40 is amended as (D) in place of (A).
 - c) The answer for question No. 42 is amended as (B) in place of (D).
 - iii. All four option for question No. 19 are correct, hence one mark has been given to each candidate.
- iv. In respect of question No. 98, both options (A) and (B) are correct and marks are awarded for both the (A) and (B) answers instead of (B).
- 3. The result of the written examination has, therefore been prepared and is being declared on the basis of revised Answer Key attached.
