

- * Consideration of Yearly Action Plan of the Council;
- * Validate the process and results of the research activities;
- * Ensure that the best technical standards are respected during the research;
- * Technical consideration of the projects received under Expression of Interest Schemes from different institutes;
- * Performance appraisal of ongoing research activities;
- * Any other issue required scientific consideration

Term of office of the above nominated members shall be three years from the date of issue of this notification or until further orders, whichever is earlier.
