ELIGIBILITY

I. Essential Qualification for the Post of Professor, Reader & Lecturer

- a Bachelor Degree in Unani from a University or its equivalent as recognized by the CCIM or NCISM under the Act; and
- a PG Qualification in Unani in the concerned subject or specialty from a University recognized by the CCIM or NCISM under the Act;
- The in-service candidate shall have completed his PG in concerned subject before the completion of 45 years of his age.
- a valid Registration with the concerned State Board or Council where he is employed or a valid Central or National Registration Certificate issued by the CCIM or NCISM.

II. Experience for the Post of Professor, Reader & Lecturer

A. Experience for the Post of Professor

- Ten years of teaching experience as Regular Teacher in the concerned subject or five years teaching experience as Associate Professor or Reader on regular basis teaching in the concerned subject; or
- Ten years research experience as fulltime researcher (after possessing Post Graduate qualification in the concerned subject) in Research Councils of Central Government or State Government or Union territory or University of National Institute or National Accreditation Board for Testing and Calibration Laboratories (NABL) accredited Research Laboratory or ten years of experience in regular service (after possessing post

graduate qualification in the concerned subject) in Central Government Health Services or State Government Health Services, Ministry of AYUSH or ten years of experience (after possessing Post-graduate qualification in the concerned subject) as Assistant Registrar or Registrar in Central Council of Indian Medicine having qualified National Teachers Eligibility Test from the date it is operational, and

(ii) With any one of the following three criteria, namely:

- (a) Minimum of five research articles published in indexed journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus); or
- (b) Minimum of three research articles published in indexed journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus) and 01 Published book or Manual relevant to Unani; or
- (c) Investigator for any major research project (duration of the project three years and above as per the sanctioned letter).

B. Experience for the Post of Reader

- (i) five years of teaching experience as regular teacher in the concerned subject; or
- (ii) five years of research experience as fulltime researcher (after possessing Post-graduate qualification in the concerned subject) in Research Councils of Central Government or State Government or Union territory or University or National Institutions or National Accreditation Board for Testing and Calibration Laboratories (NABL) accredited Research Laboratories or five years of experience in regular service (after possessing Post-graduate qualification in the concerned subject) in Central Government Health Services or State Government Health services, Ministry of Ayush' or five years of experience (after possessing Post-graduate qualification in the concerned subject) as Assistant Registrar or Registrar in Central Council of Indian Medicine having qualified National Teacher Eligibility Test from the date it is operational, and

(iii) With any one of the following three criteria, namely:

- (a) minimum of three research articles published in indexed journals (UGC-CARE PubMed, Web of Science, Science Citation Index, Scopus); or
- (b) minimum of one research article published in indexed journals (UGC-CARE PubMed, Web of Science, Science Citation Index, Scopus) and 01 Published book or Manual relevant to Unani; or
- (c) Investigator for any major research project (duration of the project three years as above as per the sanctioned letter) or minor research project (duration of the project less than three years as per the sanctioned letter).

C. Experience for the Post of Lecturer

- No teaching experience is required for the Post of Lecturer.

III. Age Limit for the Post of:

- Professor: Age shall not exceed 55 years
- Reader: Age shall not exceed 50 years
- Lecturer shall not exceed 45 years

2. The candidates not fulfilling eligibility criteria/ appearing with incomplete documents will not be considered for selection process.
3. Eligibility of Candidate in respect of age will be determined as on date of Interview and Relaxation in age will be as per Government of India Rules.

4. The engagement shall be purely on Contractual Basis initially for a period of one year or till the posts are created and filled up on Regular Basis, whichever is earlier and terms extendable for further period as decided by the CCRUM/RRIUM from time to time subject to satisfactory work & conduct.
5. The appointee shall not be granted any claim or right for regular appointment to any post of the Council.
